FLU SEASON

Flu season is fast approaching, and health experts are predicting a worse than average flu season this year. Delta Health is hosting multiple **Flu Clinics in Classroom A** in the next few months. The vaccine is provided at no cost to all employees, medical staff, volunteers, students, travelers and family members who are on Delta Health's health insurance plan. Watch for Flu Clinic dates posted throughout the hospital.

Flu Vaccine policy S5030 is posted on the intranet under the hospital's safety policies. All providers at Delta Health must be vaccinated with the Influenza vaccine no later than **Dec 15th**. Those with an approved medical or religious exemption will be required to wear a mask at all times while at work for the duration of the flu season. Those with a flu sticker on their badge do not have to wear a mask while in the hospital.

Excellence Every Patient Every Time

Our Patient Survey (CAHPS) results are **up!**

This is the first time we have seen an increase since Feb.

Due to Delta Health's focus on **excellence**, for **every patient, every time**, we are seeing a slow improvement in how our patients are rating their hospital experience.

Something we noticed in our survey comments: Patients remember when their provider sits down as they come into their room and greet them by their first name. Delta Health Finances

Sep 2022 financials resulted in a net gain from operations of \$265,142.

YTD our net income is (\$1,236,731).

Medicare/Medicaid revenue hit 75.8% of total revenue in Sep, averaging 76.9 for the year.

REVENUE

Hospital gross revenue for Sep was \$17,795,529. Deductions from revenue were more than budget by \$1,810K. Net revenue % for Sep was 35.92%.

EXPENSES

Total operating expenses were more than budget by \$469K. Contract labor increased in Sep. Admin met with FEMA reps and hope to submit final application this month. If approved, we hope to have funds before the end of the year.


