#### CRNAs, NPs and PAs Ask For Medical Staff Vote

Introduced at the Med Staff dinner meeting on Mar 15th:

Delta Health's AHPs would like to vote on medical staff ballot issues. This is not a request for AHPs to sit as Chair on any service committee or become part of the Med Exec. This is not a request for the AHPs to form their own committee. The AHPs feel well represented in their clinic teams, and are very involved in the surgery and outpatient medicine committees.

Joe Jones, PA said he would personally like the opportunity to vote in medical staff meetings so that he is acknowledged as a fully invested and recognized member of the medical staff team. AHPs show up to Delta Health every day to add value to this organization. Allowing the AHPs a vote on medical staff ballots shows the AHPs that they are, in turn, valued as a member on the medical staff, as well. It is an honor to vote in a country that offers voting freedom. There are several countries that don't. PA Jones said that he would appreciate and welcome the opportunity to vote on matters that affect all members of the medical staff team.

PA Jones added that in the interest of being fully transparent, this request does not include any political motivation. This is not tied to any legislative proposal; for example to change physician supervision of PAs or to change the scope of practice of NPs in the emergency department.

Dr. Nickel commented that AHPs are currently asked to pay med staff dues, but are not allowed to vote. He considers this taxation without representation. He recommended that this Bylaw rule be amended; if AHPs pay dues—they should be allowed to vote. If they are not allowed to vote, they should not be charged a med staff fee.

Dr. Abuid added that NPs and PAs are the primary care provider of many of our community's patients. When this issue was brought up in the past, many physicians did not have experience working with AHPs because we did not have any on staff. Things have changed over the years. Gwen Conrad confirmed that we currently have 3 PAs, 7 NPs and 6 CRNAs on staff for a total of 17 AHPs.

Dr. Freese feels strongly that the Med Exec Committee should be physician-led. It would not be fair to expose AHPs to some of the issues that are forwarded to the Med Exec level. Our bylaws currently state that Chairs are to be physicians, and Dr. Freese confirmed that the Med Exec is not asking to change that. The proposal is strictly, "should NPs, PAs and CRNAs be allowed to vote". Dr. Freese added that it would be a huge recruitment tool to tell future AHPs that they are invited to be voting members on the medical staff.

The Med Exec will put this to a vote to the Med Staff 30 days before the next Med Staff meeting on May 23rd. Please share your comments with your Committee Chair or Chief of Staff before the next Med Exec meeting on Apr 12th. Comments can also be sent to gconrad@deltahospital.org. Thank you!
