EXECUTIVE REPORT & FINANCIALS: Kaitlyn informed the group our **name change** is set to be in effect June 21st. The website has been updated. There is an additional underwriter level limited to 3 sponsors at \$1,500 to have exclusive presentation at the hydration stations. A car show is scheduled at Confluence Park that day also. Having more people at the locations will encourage food trucks to attend.
